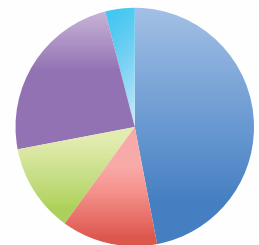

## REVENUES AND EXPENDITURES JULY 1, 2016 – JUNE 30, 2017

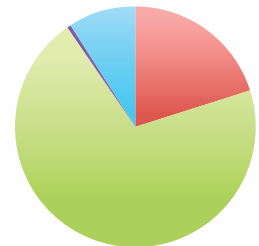
### REVENUES:
